

EMERGENCY EXECUTIVE ORDER

WHEREAS, on June 2, 2020, I, Benjamin Weinstock, as Mayor of the Village of Cedarhurst, did declare and proclaim an Emergency throughout the Village of Cedarhurst relating to imminent threat to the safety and well-being of the Village community; and

WHEREAS, such imminent threat was perceived after becoming aware of media reports of physical violence, including assault, vandalism, property damage and/or looting and/or other acts of violence stemming from the acts of persons using peaceful lawful demonstrations as their springboard into violence; and

WHEREAS, such threat was further confirmed by consultations with appropriate law enforcement officials, and

WHEREAS, the violent acts have been happening primarily during the hours of darkness, and it is especially difficult to preserve public safety during such hours, and

WHEREAS, the imposition of a curfew is necessary to protect the Village and its residents from severe endangerment and harm to their health, safety and property;


NOW, THEREFORE, pursuant to the powers vested in me by the laws of the State of New York and the Village of Cedarhurst, including but not limited to the New York Executive Law § 24(1)(a), and the common law authority to protect the public in the event of an emergency, and pursuant to the state of emergency proclaimed by me, and I hereby

ORDER a Village-wide curfew from 7:00pm on June 2, 2020 until 6:00 am on June 3, 2020; and I do further

ORDER that during this time, no persons or vehicles may be in public; and I do further

ORDER that this Order shall not apply to police officers, peace officers, firefighters, first responders and emergency medical technicians, individuals travelling to and from essential work and performing essential work, and individuals seeking medical treatment or medical supplies. "Essential work" is work performed by essential businesses or entities as defined or permitted by the Empire State Development Corporation.

This Order shall take effect immediately. This Order shall remain in effect through June 3, 2020 unless rescinded, superseded, extended or amended by further Order. Failure to comply with this Order shall result in orders to disburse, and any person who knowingly violates the provisions in this Order shall be guilty of a Class B misdemeanor.

EMERGENCY PROCLAMATION

WHEREAS, current nationwide civil unrest has include numerous incidents of riot, looting and other forms of violence, and

WHEREAS, in order to protect the people of New York City from assault, vandalism, property damage and/or looting and/or other acts of violence that have unfortunately repeatedly taken place by persons utilizing lawful peaceful demonstrations as their springboard, the Mayor of the City of New York has issued an Executive Order establishing a curfew in New York City, a metropolis geographically proximate to the Village of Cedarhurst, and

WHEREAS, it has come to my attention through various media and other sources that lawful peaceful demonstrations are planned in neighborhoods of both New York City and Nassau County which are proximate to the Village of Cedarhurst, and


WHEREAS, it is reasonable to believe that the same opportunities for some persons to utilize such peaceful demonstrations as their springboard into unlawful violence, and

WHEREAS, the Village of Cedarhurst, which lacks its own police force, but in consultation and cooperation with appropriate law enforcement officials, must now confront the imminent threat of violence by persons using the springboard of lawful and peaceful demonstrations, and must employ the tools given to it by the State of New York through its Executive Law to deal with emergencies, including the issuance of local emergency orders to protect life and property and to bring the emergency situation under control;

NOW, THEREFORE, I, Benjamin Weinstock, Mayor of the Incorporated Village of Cedarhurst, New York, by virtue of the authority vested in me by the Laws of the State of New York, hereby proclaim and declare, pursuant to Section 24 of the New York State Executive Law, that a local State of Emergency exists in the entire Village of Cedarhurst, New York, and I hereby exercise this authority in order to preserve the public safety and so as to be best able to render all required and available assistance vital to the security, well-being and health of the citizens of this Village; and

I do hereby proclaim a local State of Emergency for the entire Village of Cedarhurst.

This Proclamation shall be in effect immediately and shall remain in effect for thirty (30) days, unless rescinded earlier by my order.
