**ACCEPTING BID TABULATION AND AWARDING CONTRACT FOR
PARKING FIELD #10 EXPANSION PROJECT
BID NO. TI-2026-002**

WHEREAS, the Incorporated Village of Cedarhurst duly advertised for sealed bids for Streetlight Maintenance Services pursuant to Bid No. TI-2026-001, in accordance with New York State General Municipal Law §103; and

WHEREAS, sealed bids were received and publicly opened on February 02, 2026, and thereafter reviewed by the Village; and

WHEREAS, the Village Clerk-Treasurer prepared and certified a bid tabulation reflecting the bids as submitted by the bidders; and

WHEREAS, the Board of Trustees has reviewed the certified bid tabulation and finds it to be complete and accurate; and

WHEREAS, based upon the bid pricing structure and anticipated usage of services, the Board of Trustees has determined that Watral Brothers, Inc. is the lowest responsive and responsible bidder in the best interest of the Village;

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of the Incorporated Village of Cedarhurst hereby accepts the certified bid tabulation for Bid No. TI-2026-002, as submitted by the Village Clerk-Treasurer; and

BE IT FURTHER RESOLVED that the contract for Parking Field #10 Expansion Project (Bid No. TI-2026-002) is hereby awarded to Watral Brothers, Inc., in accordance with the prices, terms, and conditions set forth in its bid submission; and

BE IT FURTHER RESOLVED that the award of the contract to Watral Brothers, Inc. is expressly conditioned upon the submission and review of all required insurance certificates, endorsements, and performance and payment bond documentation, in forms acceptable to the Village and the Village Attorney, and the Mayor is authorized to execute the contract only upon confirmation that such documentation complies with the requirements of the bid specifications and applicable law.

BE IT FURTHER RESOLVED that the Mayor is hereby authorized to execute the contract, and the Village Clerk-Treasurer is authorized to take all actions necessary to implement this resolution.
